## 1. Purpose and Identification

## 2. Service Description

YFBoard is an intensive professional American English training platform (Executive English).

The service includes:

- A structured 100-hour educational path [cite: 1jSpaMTsYRaDTaQJUTuq4CJla1BzfH0129LKH0c7VM9Q].
- 90 days of Premium access to conversational AI (Linda) and the voice analysis tool (AlphabetGrid) [cite: 1jSpaMTsYRaDTaQJUTuq4CJla1BzfH0129LKH0c7VM9Q].
- An optional free practice bonus of up to 18,000 minutes of AI conversation.

## 3. Account Management and Security

**Personal Nature:** Account creation is strictly personal and private. An account may only be used by one natural person.

**Confidentiality:** The user is solely responsible for the confidentiality of their login credentials (email) and password. They agree not to share, assign, or disclose them to third parties. Any activity performed on the account is deemed to be performed by the user.

**AI Security:** The use of the Linda AI is strictly reserved for learning English. Any attempt at misuse, jailbreaking, or inputting illicit content (hate speech, pornographic, violent) will result in immediate account suspension without refund.

## 4. Financial Terms and Payment

**Price:** The total price is **€1,380.00 (Including Tax)** (€1,150.00 excluding tax + €230.00 VAT) [cite: 1\_iHEOI2prnSEP0A0sm8JM-EHVRGEpCG3Ly8wscA\_5vc].

**Methods:**

- Full payment via Stripe or PayPal [cite: 1\_iHEOI2prnSEP0A0sm8JM-EHVRGEpCG3Ly8wscA\_5vc].
